Guidelines:

Number: One dvar Torah per boy per edition. However you can also enter the quiz questions.

Source: The dvar Torah/Story can be taken from a book but the source should be quoted and you should put it into your own words.

Length: 230-320 words

Format: i) Provide a title ii)The dvar Torah/Story should be

typed in Microsoft Word. iii) Pesukim of 3+ words can be written in Hebrew, but single words like Moshe Rabbeinu should be typed in English. iv) The boy should write his age. **Raffle:** A boy can only win once per edition, but gets a ticket

for each thing he sends in.

Disclaimer: The panel will have final judgement.

Quiz question: Boys are allowed to go through the marei mekomot (sources) with adult help. But cannot just ask the adult for the answer.

EXPENSIVE FIRE EXTINGUISHER

Unfortunately, the taps had no water in them because the plastic had melted in the intense heat. In the terrible circumstances, Yossi resolved to save his villa come what may. Desperate, he risked his life and entered the house of his neighbor, Mr Karmer, this house had already caught fire. After a short search, he discovered a room filled with bottles and containers of fruit juice and wine. Yossi took as many containers as he could manage to carry and emptied them out onto

the fire and through his actions, he successfully prevented the fire from his damaging his house.
